able to draw a conclusion, such as inquiries primarily of persons responsible for financial and accounting

matters, and other procedures we considered necessary. The procedures performed in a limited assurance

engagement vary in nature and timing from, and are less in extent than for, a reasonable assurance engagement.

Consequently, the level of assurance obtained in a limited assurance engagement is substantially lower than

the assurance that would have been obtained had a reasonable assurance engagement been performed.

**Inherent Limitations** 

Due to the nature of cash receipts and expenses relating to the Event, it was not practicable for us to determine


whether the income and expenditure account and the books and records of the Permittee include all
